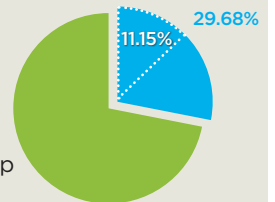

ERSTE Foundation is the main shareholder of Erste Group Bank AG.

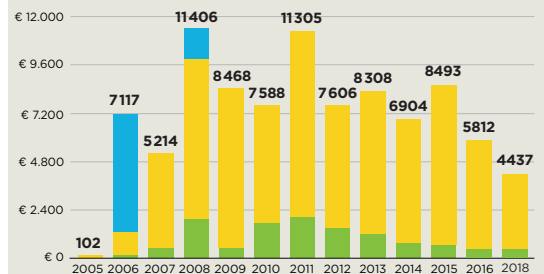


It owns a direct stake of 11,15 % and heads a group of shareholders acting in kind with 29.68 % of shares.
